This needs to be a continual and consistent effort on the Chairman's part."

DID YOU KNOW? The United States Republican Party is the second oldest currently existing political party in the United States after its great rival, the Democratic Party. It emerged in 1854 to combat the threat of slavery's extension to the territories, and to promote more vigorous modernization of the economy. It had little presence in the South, but in the North it enlisted most former Whigs, Know-Nothings and former Free Soil Democrats to form majorities in nearly every state. With the election of Abraham Lincoln in 1860, and its success in guiding the Union to victory and abolishing slavery, it came to dominate the national scene until 1932. The Republican Party was based on northern white Protestants, businessmen, professionals, factory workers, wealthier farmers, and poor blacks. It was pro-business, supporting banks, the gold standard, railroads, and high tariffs to protect heavy industry and the industrial workers.

Let's insure success in 2012—with integrity, hard work, and pride.

April 12, 2011 was a momentous day for the citizens of South Carolina. Governor Haley signed the "Spending Accountability Act of 2011" (H.3004 - Roll Call Voting Bill) into law. With this law the South Carolina Legislature moves from one of the five weakest on transparency to one of the most transparent in the country. All votes on bills or resolutions with the force and effect of law will now be recorded, so that South Carolinians may see how their representatives and senators vote. The bill passed unanimously in the House. In the Senate, the bill passed with 33 Ayes and 11 Nays. Four of the 11 who voted Nay were Republicans (Campsen, Grooms, McConnell, and Verdin).

Hopefully, another bill (H.3738), to enact the "South Carolina Health Benefit Exchange Act", is permanently buried in the House Ways and Means Committee. This bill would establish an exchange "for the purpose of facilitating the purchase and sale of qualified health plans as provided for in the 'Federal Patient Protection and Affordable Care Act'." (Obamacare) While Congressional Republicans are working to defund, and in 2013, hopefully repeal Obamacare, 13 Republicans in the SC Legislature co-sponsored this bill that would have helped implement Obamacare. After an avalanche of phone calls and emails from their constituents, these 13 Republicans (Cooper, Brannon, Pitts, Allison, Lucas, Parker, Huggins, Loftis, Owens, Barfield, Hardwick, Horne, and Herbkersman) removed their names as co-sponsors. According to *The Washington Post*, the Health Insurance Exchange is the, "most important aspect of health care reform." The federal government will use these Exchanges to enforce the requirement that everyone buy government-approved health insurance. Per Michael Cannon, Director of Health Policy Studies at the Cato Institute, "Affordable plans will disappear because Obamacare requires all purchasers to buy whatever coverage Sebelius [Secretary of HHS] mandates as 'essential'."

On January 27, 2011, the SC House passed the "South Carolina Election Reform Act" (H.3003), which requires a photo ID to vote. What an outlandish idea to require voters to provide proof that they are legitimately voting. Just as last year, the SC Senate is fighting the bill. Some Senators say the bill is unfair to minorities and elderly voters who do not have a driver's license. The bill requires that the Department of Motor Vehicles provide free ID cards upon request. If you do not want our election system to be at the mercy of ACORN (ACORN officials have pleaded guilty to voter fraud) and other such organizations, please contact your Senator and ask him to vote for the "SC Election Reform Act".

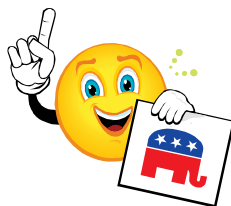
