United States Senator Jim DeMint

United States Congressman Trey Gowdy - 4th District South Carolina

The Greenville Country Republican Women's Club along with the Upstate Republican Women's club are proud to have as our guest speakers - U. S. Senator Jim DeMint and U. S. Congressman Trey Gowdy.

Senator Jim DeMint

Since his first campaign for Congress in 1998, Jim DeMint has proven to be a principled leader that has fought to secure South Carolina's and America's future.

Elected as South Carolina's 55th senator in 2004, DeMint quickly established himself as one of the most effective conservative leaders in Washington, seeking to enact innovative solutions to improve America for future generations. He has been a tireless advocate for smaller government, individual liberty, a strong national defense and traditional values. DeMint has earned national acclaim for his work to end the system of earmarks, also referred to as the "congressional favor factory." Following the November elections in 2006, the senator stood up against big spenders in Congress and stopped over 10,000 wasteful pork projects. Famed Washington journalist Robert Novak called him a "hero." *Wall Street Journal* editor Steve Moore said the senator's actions saved Americans about \$17 billion and called him the "taxpayers' greatest ally." In early 2007 DeMint also fought for commonsense immigration reform by leading the effort to defeat the amnesty bill and calling on government to first secure our borders, enforce the laws already passed, and streamline the legal immigration system.

In late 2006, he was elected as chairman of the Senate Steering Committee, which is comprised of the majority of Republican senators and works to advance conservative legislation. Last year, just as Ronald Reagan had done over 20 years earlier, DeMint delivered the keynote address to the nation's largest gathering of conservative activists at the annual Conservative Political Action Conference (CPAC). He was recently ranked as the Senate's most conservative member by *National Journal* and as the No. 1 senator voting for responsible tax and spending policies by the National Taxpayers Union. DeMint understands the greatness of a country is found in its people and values, not in its government. The senator and his wife, Debbie, reside in Greenville, South Carolina and are the proud parents of four married children. They are also greatly enjoying their new role as grandparents.

Trey graduated from Spartanburg High School in 1982, Baylor University in 1986 with a degree in History, and the University of South Carolina School of Law in 1989 where he was a member of the scholastic honor society “Order of the Wig and Robe”.

For 6 years as a federal prosecutor, Trey prosecuted the full range of federal crimes including narcotics trafficking rings, bank robberies, child pornography cases, and the murder of a federal witness. He was awarded the Postal Inspector’s Award for the successful prosecution of J. Mark Allen, one of “America’s Most Wanted” suspects. He also received the highest performance rating a federal prosecutor can receive – two years in a row.

As 7th Circuit Solicitor, Trey led an office of 25 attorneys and 65 total employees. During his tenure, he started a Violence Against Women Task Force, a Worthless Check Program, enhanced and expanded Drug Court, and implemented a Drug Mother Protocol designed to assist expectant mothers break the cycle of addiction.

He has been recognized statewide for his commitment to victim’s rights, drunken driving enforcement, and nationally for excellence in death penalty prosecutions.

Trey is married to Terri Dillard Gowdy, and they have two children: Watson and Abigail. Terri works for the Spartanburg School District as a teacher’s aide. Watson will be entering college in the fall and Abigail is a rising 9th grader at Spartanburg High School. The Gowdy family also includes three dogs: “Judge”, “Jury” and “Bailiff.”

OBAMA'S REGULATORY POWER GRAB

The Constitution of the United States of America established three branches of government – The Legislative, Executive, and Judicial. In defining the duties and powers of each branch, the Constitution created a system of checks and balances, so that no one branch could exceed the limits of its Constitutional powers. Daniel Webster stated, "... I am committed against every thing which, in my judgment, may weaken, endanger, or destroy [the Constitution]... and especially against all extension of Executive power; and I am committed against any attempt to rule the free people of this country by the power and the patronage of the Government itself..."

These are just a couple of the ways Barack Obama has exceeded the limits of the powers of the Executive branch. 1. The Cap-and-Trade bill was not passed by the Senate, so Obama's Climate Czar, Carol Browner, who was not confirmed by the Senate, is implementing the global warming agenda at the EPA. The EPA declared carbon dioxide to be a pollutant. The EPA is using this false premise to establish new regulations which will force industries to move out of our country, kill more jobs, and increase the cost of everything we buy. According to 142 expert scientists with the International Climate Science Coalition, "Carbon dioxide is not a pollutant – it is a necessary reactant in plant photosynthesis and so is essential for life on Earth." Having failed to get net neutrality passed in Congress, Obama turned to his friend, Chairman of the FCC, Julius Genachowski, to implement net neutrality restrictions on the Internet. On April 6, 2010 the DC Circuit Court of Appeals ruled that the FCC did not have authority to regulate the Internet. The FCC ignored Congress, the courts, and the American people and voted on a 3-2 party line vote to impose destructive regulations on the Internet. There are many more examples of Obama's regulatory extremism- Union Card Check, ObamaCare, Financial Regulations, etc.

A bill has been introduced which could put the brakes on Obama's power-grab. The "Regulations from the Executive in Need of Scrutiny (REINS) Act" would require a "yes" vote of Congress before any major new regulations could take effect. H.R. 10 is co-sponsored by four of our South Carolina Congressmen: Tim Scott, Joe Wilson, Trey Gowdy, and Mick Mulvaney. The Senate version, S.299, is co-sponsored by Senator Jim DeMint. Considering that the Democrats control the Senate and White House, it is unlikely that this bill will become law.

The only real hope of saving our Constitutional Republic lies with the 2012 elections. It is the duty of every freedom-loving American to learn the issues, vet the candidates, and share this information with others. As James Madison stated, "A well-instructed people alone can be permanently a free people."


