Howell Clyborne is Vice President for Community and Government Affairs for the Greenville Hospital System. With more than 10,000 employees, the Greenville Hospital System, a not-for-profit academic health organization, is the largest employer in Greenville County and second largest employer in the Upstate.

Howell also serves as a member of the South Carolina Board of Economic Advisors ("BEA") whose task is to prepare and review economic forecasts and general fund revenue projections and to advise the Budget and Control Board and the General Assembly on these matters.

Howell's distinguished career in public service includes: a Greenville City police officer in 1975; Sergeant in the Greenville County Sheriff's Department 1977; Greenville County Magistrate in 1982; and Chief Magistrate in 1986. Elected to the South Carolina House of Representatives, Howell served the citizens of Greenville County District 20 from 1986-1994. While in the House, Howell founded and co-chaired the House Urban Caucus, was appointed by the Governor to the Council on Intergovernmental Relations, and was appointed by the Speaker to the Joint Senate/House University Trustee Screening Committee, the Joint Election Law Study Committee, and the Procurement Review Ad-hoc Committee. the prestigious House Ways & Means Committee, particularly on the Sales & Use Tax subcommittee, and was one of the few non-lawyers to serve on the House Judiciary Committee. In 1993, Howell was selected by his fellow House Republicans and served as Republican Minority Leader from 1993-1994. As Minority Leader, Howell played a crucial role in the major restructuring of South Carolina's state government under a plan submitted by Governor Carroll Campbell. He was the Floor leader in the re-apportionment plan which led to a Republican majority in South Carolina. Additionally, Howell was instrumental in the passing of key legislation which reformed the state government administration into a more accountable, cost effective, and responsive system for all the citizens of South Carolina.

Upon leaving the House of Representatives, Howell served on the South Carolina Tax Commission. In the fall of 1994, Governor David Beasley selected Howell to serve on his transition team and tapped him as the Director of Legislative Affairs. Soon after, Howell became Governor Beasley's Deputy Chief of Staff, which included directing the Office of Legislative Affairs. As the Governor's chief liaison with the South Carolina General Assembly, Howell was responsible for advancing the Governor's legislative initiatives, policy priorities, and the development of the executive budget. He further worked closely with cabinet agencies, assisted in the selection of various boards and commissions, and met with numerous constituent groups to discuss their concerns.

Howell is a two-time recipient of the Order of the Palmetto, the state's highest civilian honor, and the South Carolina Chamber of Commerce Public Servant of the Year award.

Howell is a graduate of Wade Hampton High School and the University of South Carolina-Spartanburg. He currently serves on the Board of the Upstate History Museum, the Health Sciences of South Carolina ("HSSC") Public Relations Committee; and is a member of the SC Hospital Association Medicaid Work Group. Howell is active in the Earle Street Baptist Church. He and his wife, Joan, have one daughter.

Promising legislation has been pre-filed for the 2011 South Carolina General Assembly session. Legislation promoting Transparency and Accountability includes:

H3004 – “Spending Accountability Act of 2011” (Roll Call Voting bill first introduced by Nikki Haley in 2009) – Representative Nathan Ballentine. This bill passed in the House of Representatives January 13, 2011. Hopefully by the time this newsletter is published, this bill will have passed in the Senate as is. All State Senators are up for re-election in 2012. This will be the first key vote used to grade the Senators.

S 311 – Requires the Department of Education to post information on its website pertaining to spending, awards, and other information related to taxpayer dollars at least 180 days prior to the use. Senators Davis, Campsen, Shoopman, Bright, Grooms, Verdin, S. Martin, and Rose

H3067 – Requires all state agencies and local government entities to maintain a searchable transaction register on the Internet. G.R. Smith, Daning, Thayer, Ballentine, and others

S206 – The Economic Incentive Transparency Act – It would require greater scrutiny on economic incentives handed out by legislators. Senators Davis, Shoopman, Massey, Bright, Bryant, Rose and S. Martin

Legislation promoting States Rights includes:

S5 – Healthcare Freedom Act – South Carolinians have the right to refuse to purchase health care insurance. Senators Leatherman, Rose, McConnell, and Campsen

S244 – Amend the Constitution by adding Section 25 to preempt any federal law or rule that restricts a person’s choice of private health care providers or the right to pay for medical services. Senator Bright

H3011 – “Freedom of Choice in Health Care Act”. G.R.Smith, Daning, Thayer, Toole, and others.

S185 – This bill would authorize the Dept. of Insurance to allow out-of-state insurers to sell plans within SC. Senator Rose.

Legislation for Budget Reforms

S10 – Creates a commission that aims to streamline government. Senators McConnell, McGill, Rose, and Campsen

S15 – Law to provide for a zero base budget process beginning with fiscal year 2012-2013. Senators McConnell, McGill, Rose, Campsen, and Verdin
