OUR SPEAKER IS ASHLEY LANDESS, PRESIDENT, SCPC



Ashley Landess, a native of South Carolina, graduated from the University of North Texas with a journalism degree. Her twenty-year career in communications includes a public policy background as well as consulting work for private businesses and charitable organizations. She is President of the South Carolina Policy Council, a non-partisan public policy research organization located in Columbia. She has been at the Council since 1998, and previously served as its Vice President for Public Affairs. Landess served on the SC Lottery Commission, the Governor's Health Care Task Force, and was appointed to chair the School District Consolidation in 2005 by Governor Sanford. Landess writes opinion columns on issues such as education reform, tax policy and government transparency. Those columns are published in dailies and weeklies across the state. Landess has appeared on statewide television and radio and has delivered expert testimony on several issues.

Ms. Landess will speak about the eight reforms needed in South Carolina government in order for the citizens of South Carolina to take the power back from the politicians:

- **Restore judicial independence—South Carolina is the only state in which the legislature unilaterally appoints judges even when vacancies arise.**
- **Make the governor fully accountable for the Executive Branch— SC lawmakers control the executive branch through a complicated web of boards and commissions.**
- **Ensure a true citizen legislature by shortening session— Our state has one of the nation's longest legislative sessions: a system that favors career politicians over citizen-legislators.**
- **Open the state's secret incentives process— Corruption is virtually guaranteed when politicians have the power to strike secret deals with private companies using public money.**
- **End lawmakers' ability to police themselves—House and Senate members police their own ethics violations.**
- **All South Carolina elected officials should report their income sources— The public has no way to ensure that lawmakers don't personally profit from legislation on which they vote.**
- **Strengthen the state's open records law and abolish lawmakers' exemption from it— There's certainly no justification for lawmakers exempting themselves from the state's Freedom of Information law.**
- **Enforce the state law that mandates an open budget process— The law requires the governor to write "the" budget and the legislature to hold "joint open hearings" to debate it.**

The last month has been a very scary time for our 2nd amendment. Since the school shooting in CT, where 20 students and 6 adults died, there have been discussions about what can be done to limit gun violence in America. Many would be open to such a discussion because no one wants to have such a massacre occur ever again. The NRA suggested we have armed guards at each school. That would give a faster response in the case of an incident. It would also deter potential threats by having an armed presence.

That suggestion by the NRA was mocked by the White House, claiming armed guards would not deter a gunman. So, over the last week, Vice President Biden has been meeting with pro-gun and anti-gun groups in hopes of coming up with a recommendation for the President to enact. Senator Feinstein (CA) plans to file a bill that would ban many "assault" weapons, limit magazine capacity, and even stop the transfer and sale of firearms. She was also the one who introduced the Assault Weapons ban in 1994 that was passed. With the split in Congress, it is unlikely that such a far reaching ban would be passed. But, not to be stopped, there is also rumor of the President using executive order to deal with this issue. Guns and ammo have been flying off the shelves since just before Christmas. Gun companies are back-ordered for 2 years, and prices have doubled and tripled on gun auction websites.

Many might ask why assault rifles are necessary. After all, we have police and the military. It all comes down to the 2nd amendment and its original intent. The people are allowed to be armed in case there is a need to defend their freedom against a tyrannical government. Since our founding fathers had just come from such a government, they knew what was necessary to defend the freedom they were about to pen. "The strongest reason for the people to retain the right to keep and bear arms is, as a last resort, to protect themselves against tyranny in government."

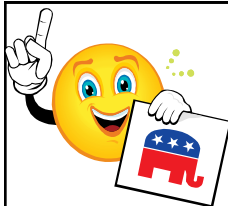
