We begin our update this month with one of the biggest topics of discussion in the political arena right now, Syria. President Obama has pressed to intervene in Syria after reports of chemical weapons being used on the people there. There is still debate on whether the government used the chemical weapons or the rebels, but we won't speculate on that here. What I'd like to focus on is a resolution working its way through Congress. A couple of weeks ago, Obama made a speech declaring that he would seek the approval of Congress before taking military action. Since that speech, members of the Senate Foreign Relations Committee met to hear testimony and draft a resolution to go before the full Senate. The resolution, as it stands today, would require Obama to attempt all diplomatic options before using any weapons of mass destruction. These weapons can only be used against the government, if the government is using the chemical weapons. It also limits our involvement to 60 days, with the possibility of one 30-day extension. Congress must be notified prior to any military strike and also be involved in any political negotiations. Finally, the resolution bans the use of U.S. troops on the ground in Syria. This resolution allows for force to be used, while putting limits on our involvement and the use of our precious resources, our soldiers, for any type of political gain.

Congress returns to Washington this week and the Senate is expected to take up the resolution mid-week. The House leadership is wavering on how to proceed related to the resolution. They might wait to see how the vote goes in the Senate. Then, if it passes, they will decide either to draft their own resolution or vote on the Senate version. Also part of the timeline is a potential filibuster by Senator Rand Paul, who believes we have no responsibility in a Syrian civil war. Many activists agree with Senator Paul's position. They believe there is no threat to the United States and that we should allow Syria to sort out its own internal issues. Those who agree with President Obama state these chemical weapons could quickly grow into a larger threat outside of Syrian borders and we should deal with that possibility by destroying those weapons now.

As mentioned in the last newsletter, there are also fiscal deadlines looming on the horizon for Congress as they return. So, after dealing with Syria, they must also deal with another continuing resolution so that government can keep functioning after the new year. They will also need to deal with the debt limit, which is fast approaching again. Keep an eye out on the news and I'll bring you more updates as decisions are made in Washington to choose the future direction of our Republic.

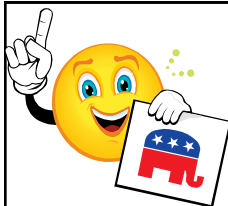
