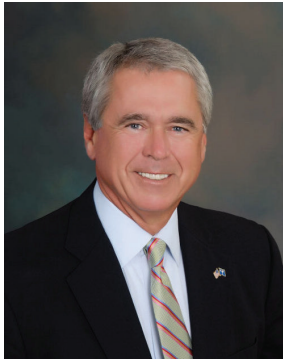

We are proud to have these men to speak with us this month. We have candidates for Senate Bill Connor, Richard Cash and a representative for Lee Bright along with the Candidate for Lt Governor Pat McKinney.



Pat McKinney has spent his entire adult life in South Carolina, working in the private sector, raising a family and serving his community. He has been married to Pam for 29 years. Pat is the proud father of three married daughters. As a small business entrepreneur, Pat understands the importance of the interaction of business and the quality of life. He and Pam are active members of St. Michael's Church in Charleston - and Pat's faith serves as the compass that guides his life. This has led him into many varied areas of community and faith-based volunteer service. Pat's South Carolina business career spans over 40 years. Pat's persistence, and God's faithfulness, led to a successful real estate career on the South Carolina coast. After working in Hilton Head, Charleston, Isle of Palms and Kiawah Island, Pat recently retired from Kiawah Partners, where he served as Managing Partner of the real estate company. Twenty-five years ago, in 1988, Pat helped organize the group of investors and personally wrote the financial model to purchase Kiawah Island from the Kuwait Investment Co. - at the time the largest single real estate transaction in South Carolina history. Richard Cash is not a typical political candidate. His life experiences include a proud father, a corporate computer analyst, a full time pro-life missionary, a volunteer youth coach and athletic director, and the founder and owner of two small businesses. A staunch conservative all of his life, Richard entered the sphere of politics in the 2010 election cycle, when he was one of eight Republican candidates who entered the race for Gresham Barrett's vacant congressional seat. As a political outsider, Richard shocked a field of better funded candidates. After winning the original primary vote, Richard narrowly lost a run-off to Rep. Jeff Duncan, who has gone on to represent the third district admirably in Washington. Richard's life experiences and his uniquely passionate message have prepared him to enter the sphere of politics once again. Richard graduated Magna Cum Laude, Phi Beta Kappa, with a degree in Economics and Business Administration. Richard worked in Greenville as a computer analyst and programmer for five years after graduating. Richard and his wife Marcia have been married for 28 years, and have 8 children. Bill Connor is a 24 year Airborne Ranger Infantry officer and Afghanistan combat veteran. He currently serves as a Lt. Colonel in the US Army reserves. Legislative Notes - - Karen McManaway

Medical Marijuana May be Legalized

Our Representative, Jenny Horne, has introduced a bill named "Julian's Act." It was named after a 3-year old constituent who suffers daily with dozens of seizures. The family will be relocating to Colorado so that their daughter will have access to cannibidiol, which is oil derived from marijuana. This bill will make this liquid legal and accessible if a patient has a prescription from a doctor or is participating in a clinical trial for treating severe forms of epilepsy.

Under the bill, doctors will be protected from being arrested or sued for prescribing or providing the oil in limited circumstances. Rep. Kris Crawford, who is a doctor, stresses that this bill is not intended to legalize marijuana for recreational purposes, but it could really make a difference for those suffering from extreme forms of epilepsy.

Democrat House Minority Leader, Todd Rutherford, has also introduced a bill to legalize marijuana for medical use, but is not as restrictive as the Republican bill. His version would allow residents with a debilitating medical condition to register with DHEC to legally use marijuana.

There are over 104,000 people in our state that is been diagnosed with epilepsy with 2,100 new cases diagnosed annually. Founder of the SC Advocates for Epilepsy, Karen St. Marie as asked legislators to broaden the bill to other monitored consistent sources, but Republicans want to take it a one small step at time to limit abuse.

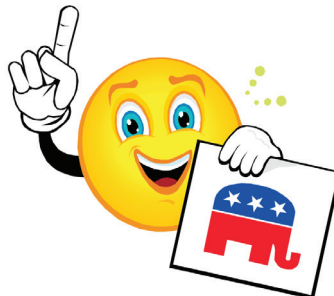
