Rocky Roads Ahead?

The road tax was defeated in the November election on a county level, but on a state level, our lawmakers aren't ready to throw the towel in just yet.

Sen. Nikki Setzler, leader of Senate Democrats, recommends creating a fund for improving our interstate by taking sales tax on cars and leveraging it with revenue bonds to accumulate almost \$600 million per year.

Rep. Tommy Stringer, has pre-filed two similar bills that creates a tool to transfer non-federal aid secondary roads from state to county control for up to 21,000 miles of secondary roads now in the state's road inventory to county government. Why 21,000? These are considered secondary roads and are not eligible for federal aid and these roads should be managed by the counties according to Rep. Stringer.

Rep Stringer states that SCDOT manages the 4th highest number of road miles as compared to other states and before SCDOT can be reformed, its true scope and mission must be decided. The SCDOT should be concentrating on improving our overall state road system, not the two lane road in your neighborhood.

The bills that have been pre-filed are identical except for the funding method and a tax credit. One bill carves out funds from the existing gas tax. The other bill increases the gas tax while granting an income tax credit as an offset. The funds will flow through a newly created T-fund and are designated to be used only to improve current roads during the transfer process. These bills have a sunset provision. Once the transfer is completed, the T-Fund is eliminated.

The carving out funds from the existing gas tax may survive, but the bill that increases our current gas tax may have little chance of survival as Gov. Nikki Haley has threatened to veto any increase in the gas tax. A problem for both bills may be that some county officials have already made it known that they are not happy about the idea of accepting state roads within their jurisdictions, citing a lack of trust, money, and expertise.


