## **January 28: Candidates** **Christina Jeffrey 4th Congressional** **Leighton Lord Attorney General**

### **CHRISTINA JEFFREY**

Dr. Jeffrey, Republican candidate for Congress in South Carolina's Fourth Congressional District, is a life-long conservative activist.

She began her academic career in the University of Georgia system in 1987, and was a tenured professor at Kennesaw State University. She is the author of numerous academic publications many of which focus on America's founding fathers and the United States Constitution.

### **LEIGHTON LORD**

Like many South Carolinians, **Leighton Lord** was born on a military base while his father served in the U.S. Army. He has been married for the past 18 years to the former Caroline Averyt of Columbia and has three children, Isabelle, 9; Owen, 12; and Will, 15.

Leighton attended the University of Delaware. After graduating from Vanderbilt Law School and completing a prestigious judicial clerkship and while still in his 20s, Leighton took on one of the most important crime-fighting jobs in the nation: Republican Staff Counsel to the U.S. Senate Subcommittee on Investigations.

Leighton left Washington to enter private practice in South Carolina with one of the State's top law firms, Nexsen Pruet. As a litigator, he has been involved with cases in both State and Federal Court; has represented the State on a number of occasions; and has broad, deep experience working with various South Carolina government agencies.

His professional achievements have not gone unnoticed. Leighton's peers have ranked him at the highest levels for competence and ethics by Martindale- Hubbell Legal Rankings, and he has been rated among the best attorneys in South Carolina by the state's lawyers.

At the age of 42, Leighton was elected Managing Partner of Nexsen Pruet, a firm twice the size of the Attorney General's office, making him one of the youngest managing partners of a major law firm. This has given him critical first-hand experience in running a large business, managing attorneys, and building consensus. He led his firm's involvement in negotiating the expansion of Boeing in North Charleston in October 2009. **Jamie Bach**

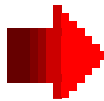

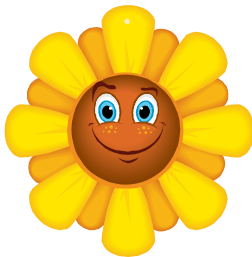
## Health Care Reform- A Fait Accompli?

According to the January 14<sup>th</sup> Quinnipiac poll on health care reform, 34 percent mostly approve, while 54 percent mostly disapprove. Yet, the Democrats are forging ahead. The last few days top Congressional Democrats have been gathered in the White House in secret negotiations to work out their remaining differences on health care legislation. It was just announced that the White House has reached a deal with negotiators and labor unions on taxing the high-level “Cadillac” plans. This sweetheart deal for the unions removes the last biggest sticking point in the health care negotiations. It seems that in Obama’s version of the Constitution, three branches of government write legislation: the Executive, Legislative, and Union branches.

The Democrats are moving quickly to finish negotiations and send the bill to the CBO for cost estimates. One reason for their haste is that Scott Brown, the Republican Senate candidate in Massachusetts, may win the Special Election on January 19<sup>th</sup>. Brown has made it clear he will vote against the Democrats’ health care bill. His vote could stop ObamaCare. But to add to the long list of the Democrats’ dirty tricks (bribing members of Congress, sweetheart deals for unions, etc.), it appears that they are ready to stall seating Brown, if he wins. It was reported in the Boston Herald that the Secretary of the Commonwealth, a Democrat, may wait until February 20<sup>th</sup> to certify the race.

If the Democrats succeed in passing arguably the worst piece of legislation in the history of the United States, all may not be lost. The Constitutionality of ObamaCare is in question. Florida Attorney General, Bill McCollum, is ready to take healthcare reform to court. The “individual mandate” appears to exceed Congress’s power under the Commerce Clause of the Constitution. South Carolina Attorney General, Henry McMaster, and twelve other state attorneys general are prepared to challenge the Constitutionality of bribes, such as the Nebraska kickback. Per Ken Klukowski with the American Civil Rights Union, the provision in ObamaCare that probably violates the Tenth Amendment is the state exchanges. Two Supreme Court decisions in the 1990s resulted in the “anti-commandeering principle” – holding that the Tenth Amendment forbids the federal government from ordering any branch of state government to do anything.

There are other plans to fight ObamaCare including: State Sovereignty Bills, Nullification, and organizations starting nationwide efforts to repeal it. *Debbie Spaugh*

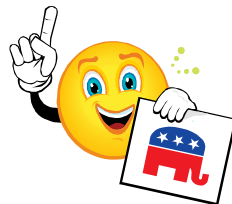
